Stall pricing: \$10, powered sites cost \$10 extra. Stalls are to be set up between 6am and 8am on Saturday 15th October 2016. Entertainment is starting at 9am continuing in various stages until midnight. On notification of your successful application payment will be required - the stallholder coordinator will contact you. **Bookings are only valid upon payment received. Fees are non-refundable. Biggenden and surrounds local Not-For-Profit Organisations do not have to pay stall fees,** however you will have to book your site using this form.

I confirm that I have or will obtain the appropriate licenses (food licensing) and abide by all Health and Safety requirements associated with these licenses. I confirm that I will ensure safe operation of the stall and prepare and set it up with a large crowd in mind – avoiding risks like unmarked tent pegs & lines, open heat sources and so on. I will provide an appropriate fire extinguisher for my stall where warranted. I agree that if my stall and its operation is identified as a Health and Safety Risk during the event, Safety Inspectors may have to demand the immediate shut down of operations with which I will comply without any option for financial reimbursement. It is my responsibility to avoid this scenario by obtaining all required information and licenses prior to the event and have the licenses ready upon request throughout the event. It is my responsibility to insure risks associated with running my stall. Public liability insurance is compulsory for all Stallholders. A copy of your current Certificate of Currency must be forwarded with this application.

I give consent to Biggenden APEX Rose Festival to make, use and/or retain any image/s that may identify me or an individual working at the stall. I understand that I can withdraw or modify my consent at any time in writing to info@rosefestival.com.au

I acknowledge that this Festival is an activity which carries a certain amount of risk including the potential for serious injury and property loss.
